### CT EAPA MEETING MINUTES 1/16/2025

### 1. Call to order

She recently received an email informing us that EAPA International will be transferring \$300 to our chapter to reflect collection of Chapter dues.

The Chapter members donated \$470 to CT Foodshare, which the Chapter matched, for a total of \$940. We also sent a donation of \$200 to Gaylord in recognition of the fact that they provide space for our monthly chapter meetings.

For December, the starting balance was \$17,153.42, deposits were \$585.00, and expenses were \$1058.94, leaving us with an ending balance of \$16,679.48.
